Sunday: 9:00 AM: HRD Mixed (level III, Level II then Level I), sheep then goats. 11:00 AM: JBD (Levels III, Level II, Level I) and JHD (Leg 1). JHD (Leg 2) to follow conclusion of HRD runs.

### Boundary Trial Dog Course Judge: Val Manning Saturday, November 29, 2025

Optional Course Elements – Hot Chocolate Stand and Bridge with Distraction Judge Val Manning, Course Director: Dave Stanford

Start with 15+ flock in the large Free-Standing Pen (Night Pen) located 60 ft south of the Bridge Road and entrance to the moving graze. Remember that all gates must be in the same configuration as when the element began – closed gates must be closed and open gates left open before moving on to the next task.

- Level III only task Mandatory element 10 pts: Flock examination/grab and hold – Inspection for stock soundness at the Night Pen. Prior to taking the stock from the night pen, the Level 3 Shepherd and dog will enter the pen and exam the flock. The Shepherd will then grab and hold an animal designated by the judge.
- 2. Night Pen mandatory element (10 pts): Stock is removed from the pen through the gate of the pen into the Trap. The dog must prevent the escape of the flock while the Shepherd opens the gate. After the stock has exited the pen, the Shepherd closes the gate. After leaving the pen, the shepherd and flock move north towards moving graze.
- 3. Moving Graze mandatory element (10 pts): When the flock reaches the markers for the moving graze, the flock is encouraged to slow and eat their way through the graze from the south to the north.
  - a. Level 1: Shepherds guide the sheep out the north border of the moving graze then turn left towards the East Farm Road heading for their assigned stationary graze.
  - b. **Level 2:** Shepherds may move to the top of the graze (north end) to assist the dog with the reverse. Then the flock is encouraged to eat their way through the graze back to the south end.
  - c. Level 3: Shepherds are not allowed to go past the marker set 25 Ft from the northern border. The Shepherd must signal the judge when they are preparing to reverse directions of the graze. The turn of the flock should include 3 stops of the dog with the 3rd being the point when the flock reverses. The dog then exits the graze.

Once the flock reaches the south end of the graze, Level 2 and 3 Shepherds will lead them back to the East Farm Road and their assigned stationary graze.


- 4. Stationary Graze mandatory element (15 pts): The dog is responsible for keeping the flock in a designated graze area for a period. Working independently and with the flock feeling comfortable with the dog and able to eat.
  - a. Level 3 (Alternating pink & green grazes) 10-12 minutes


- b. **Level 2 –** (Alternating pink & green grazes) 7 9 minutes
- c. **Level 1 –** (Alternating white & purple grazes) 4 6 minutes Once the judge declares the graze is complete, the Shepherd and dog gather the flock from their assigned graze and head north on the East Farm Road to Manning Lane (north farm road). Everyone turns left on Manning Lane
- 5. Hot Chocolate Stand Elective element (10 pts): Midway from Richardson Road (traffic road) and the North Farm Road, there will be a Hot Chocolate stand with people sitting at the table near the road. Stock is moved past the stand with the dog and Shepherd working to keep the flock off the stand.
  - a. Level 3 The handler will settle the stock off the road across the road having the dog hold the stock while the handler accepts a mug with hot chocolate and drinks its contents. Upon finishing - the handler hands the cup back to the server and will return the stock to the road and continue to the stop sign.
  - b. Level 2 The server will bring the mug with hot chocolate to the handler in the road. The dog holds the stock in place as the handler drinks the hot chocolate. Upon finishing, the handler and dog continue on the road with the stock toward the stop sign. The dog ensures that the stock do not enter the stand.
  - c. Level 1 The servers will offer the handler hot chocolate but the handler politely declines and continues with the stock down the road. The dog ensures the stock stay on the road and does not enter the stand.
- 6. Traffic Road/Vehicle Pass: Mandatory element (10 pts): While on the road, the level 3 and 2 Shepherds will encounter a car passing from the front. The Shepherd and dog move the flock off the road to the right to allow the car to pass, then return to the road. There will be a second pass from the rear for Level 3. Level 1 Shepherds the car is stationary.
- 7. Bridge Elective element (10 pts): Level 1 and 2 lead the flock through the bridge while the dog remains at the entrance to ensure all enter, then follows through the bridge behind the flock. Level 3 The Shepherd leads the flock through the bridge, but there is a bicyclist on the other side waiting to go across after the sheep. The bicyclist converses actively with the shepherd as he walks his bike across the bridge after the dog passes. The dog should remain with the flock not follow the biker.
- 8. Re-Pen Mandatory element (10 pts): At the night pen, the dog is positioned to hold the flock off the gate to allow the shepherd access to the gate and are able to open it fully to allow the flock to enter the pen. Once everyone is in the pen and the gate is closed, time ends.
- 9. Roadwork/General Behavior-Mandatory 15 pts:

#### **Basic Course Information –**

- The course terrain is native prairie grass, due to droughty conditions

   we have a lot of granite gravel that can be harsh to some dog's feet.
- There are no "Out of Bounds" on this Course.
- Road and graze boundaries are marked by furrows with electric fence posts designating corners. Bridge is elevated gravel bottom
- Approximate course distances in feet: Level I 2570ft/ 857yards Level II 3004 ft/1001 yards Level III 3004/1001 yards
- Optional Alternate Elements: Bridge with distraction and Hot Chocolate Stand with people.
- The moving graze 303 ft/100 yards x 50ft. Level 1 stationary graze 100 ft/33 yards x 135 ft/45 yards. Level 2 & 3 stationary graze 135 ft/45 yards x 210 ft/70 yards.





## RTN - HRDm (Sheep and goats) Course Sunday, November 30, 2025 Judge: Catherine Hadley

Start with 10 head of goats in the A course arena (5 with collars, 5 without) and 10 head of sheep (5 with collars, 5 without) in the PT arena. Handler and dog enters A course from NE green gate.

- 1. **(10 pts) Gather**: all 10 goats are gathered from the arena and moved through the exhaust pen and into the alleyway.
  - a. H1 Dog is positioned halfway to the stock and handler may approach up to 15 ft of the stock.
  - b. H2 Dog is positioned at the gate and handler may approach halfway to the stock
  - c. H3 Handler and dog are positioned at the gate.
- 2. **(10 pts) Sort**: Gate Sort 5 goats into the HT arena through the alleyway gate, leaving balance in the alleyway.
  - a. H1 sort any 5 goats
  - b. H2 sort at least 3 with a collars
  - c. H3 sort 5 with collars or 5 without collars
- 3. **(10 pts) Free-standing Pen:** Pen the 5 goats in the HT arena into the free-standing pen.

Dog and Handler enter the PT arena to the take pen at the SW corner

- 4. **(10 pts) Take Pen:** Sheep are removed from the pen and moved them to the handlers post (orange cone).
- 5. **(10 pts) Fetch/Drive:** From the cone, fetch/drive to the Northwest corner of the arena and turn clockwise around panel fetch/drive sheep to the northeast corner around the panel. Proceed to PT holding pen in southwest corner of arena.
  - a. H1 Fetch/drive the stock
  - b. **H2** Fetch/drive to the H2 handler's line, then dog must drive the balance until stock are around the east panel.
  - c. **H3** Fetch/drive to the H3 handler's line, then dog must drive the balance until the stock are around the east panel.


- 6. **(10 PTS) Exhaust**: Repen Sheep into the PT exhaust pen with a hold off the gate.
- 7. **(10 pts) Chute/gatework:** Handler and dog enter exhaust pen and 10 head stock is run through the handling chute. Once livestock are in the chute, the entrance gate is closed, guillotine gate is lowered, and dog and handler go through the alleyway and sorting pen to the east side of the handling system, leaving gates open. The handler opens the gate to the sorting pen and using the silver sorting gate, allows the sheep access to the sorting pen. Dog and handler then follow sheep back into the larger PT holding pen and exit. (H3 Handler returns back to the handling system pen)
  - a. H1 & H2- All stock is sorted into the sorting pen.
  - b. H3 Using the sorting gate, stock is sorted by those with collars and those without. 1 group is sorted into the sorting pen, the others are released into the handling system pen.
- 8. **(10 pts) \* H3 Special Task:** Stock sorted into the handling system pen are gathered and moved through the side gate back into the PT holding pen.

Dog and handler return to the HT arena.

- 9. **(10 pts) Unpenning/gatework**: Unpen the goats from the free-standing pen and repen into the alleyway with the other goats.
- 10. **(10 Pts) Gatework/alleyway**: Take all the goats through alleyway and exhaust into the A course

Time Ends when handler and dog exit the north HT arena gate.

Tie breaker #1 – Best score on #7
Tie breaker #2 – Best score on #2
